STAIN TREATMENT:

Products that are readily available to the domestic market were used to treat the stains for example: Troubleshooter 1001 (for carpets & upholstery) & the Stain Devils Range.

TREATMENT FOR WET SIDE SAMPLE:

Using the 1001 cleaning spray & Stain Devil on the affect areas. Each area was sponged then dried with kitchen role to wipe away the stains.

TREATMENT FOR DRY SIDE SAMPLE:

Using Nail Polish Remover (Acetone Free) & Stain Devil on the affect areas.

- Some Fats and oily substances can be removed with upholstery cleaner and detergent
- Light disinfectant can be used (do not soak / no prolonged use)
- Any cleaning fluids that contain strong solvent will damage/discolour fabric.
- Avoid marking with BBQ Sauce, Lipstick L'Oreal, Nail Varnish and Ball Point pen.
